- **Engage proactively with community & government, industry sectors**

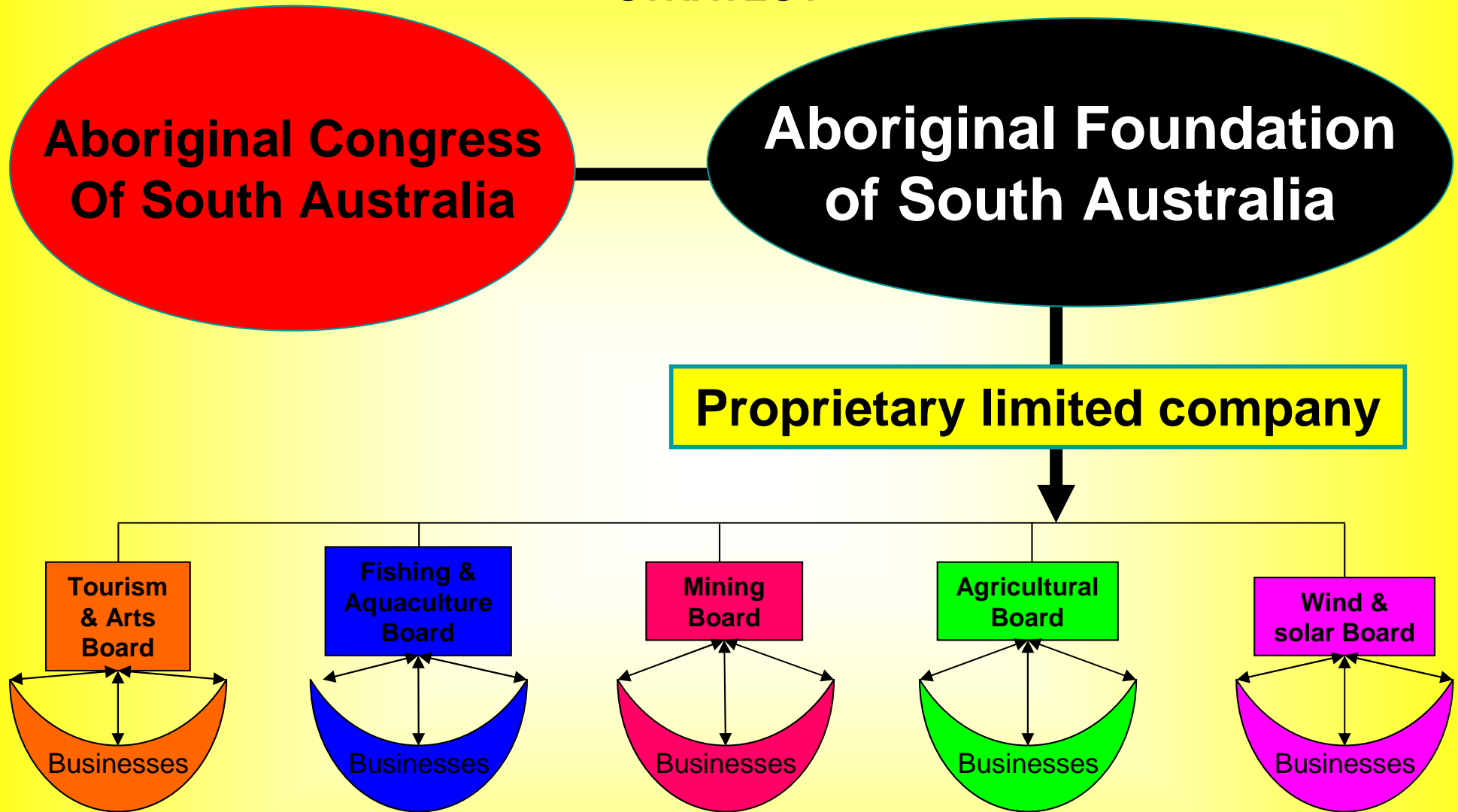

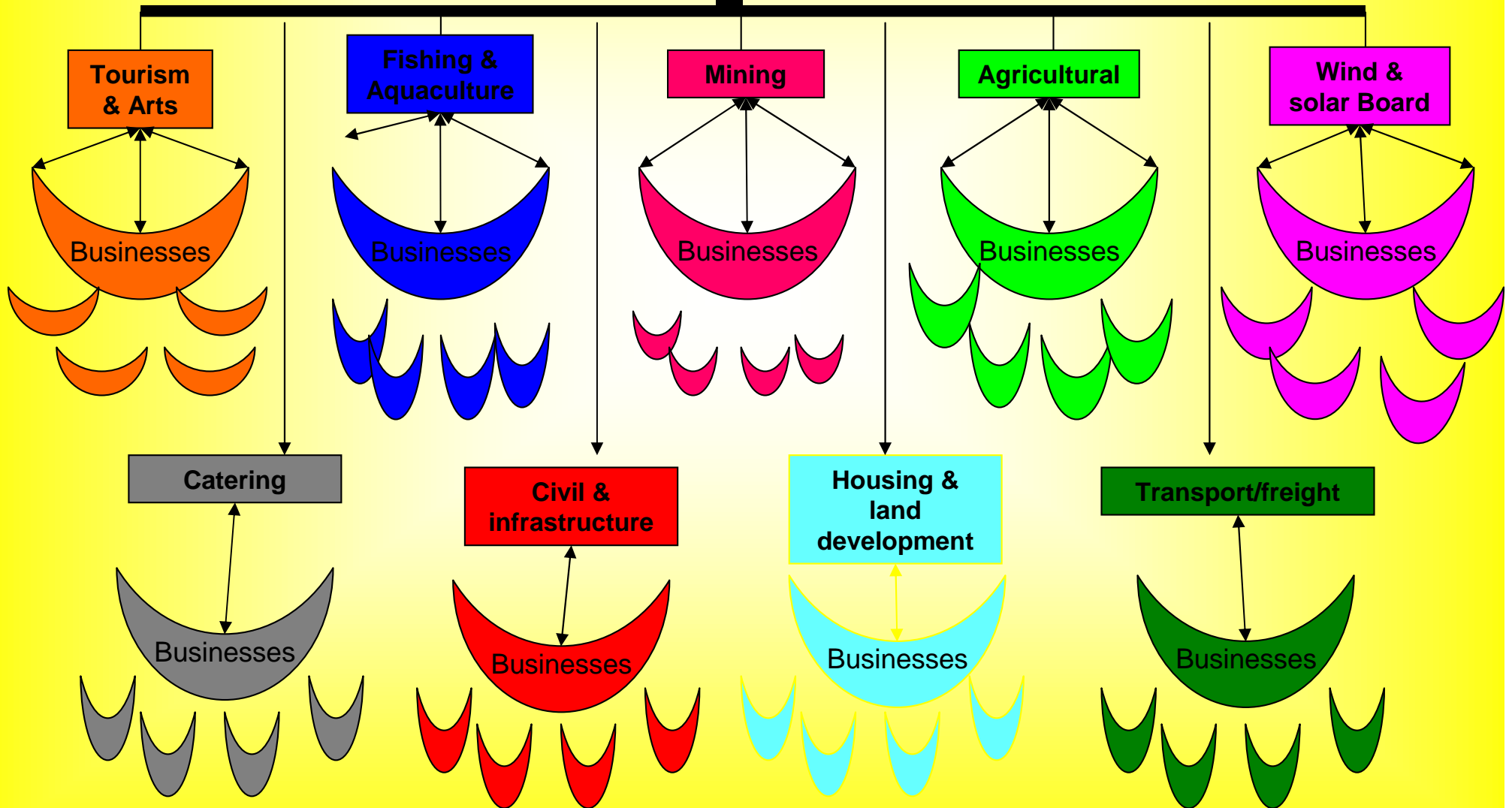
